Although the infrastructure required for trading and clearing is fully operational, the pace of market adoption remains slow. The primary constraint has been identified as a knowledge gap among key market participants, limiting their ability to fully engage with the available offerings.

In response, NG Clearing is actively pursuing a strategy centered on education, capacity building, and collaboration with stakeholders. Sustained engagement remains essential to deepen understanding, foster trust, and accelerate uptake across the ecosystem.

Through structured training and continuous stakeholder engagement, NG Clearing seeks to deepen the understanding of derivatives products. The long-term objective is to close the prevailing knowledge gap and enhance overall market confidence and participation.

Collaborative Curriculum

This was done in collaboration with key stakeholders across the ecosystem, ensuring relevance and practical alignment with the Nigerian market.

Training Roll-out

The curriculum is set to be rolled out in the coming months. The target audience includes market operators, institutional investors, and regulators.


The training is expected to serve as a foundational step toward building widespread market competence in derivatives trading and clearing.

As part of our product diversification strategy, we are currently partnering with various stakeholders to launch new instruments that cater to both local and global investment interests, as follows:

- **Commodity Derivatives** to support Nigeria's growing commodities ecosystem, with an initial focus on agriculture.
- **Gas Exchange Derivatives** to explore the energy markets by developing instruments that facilitate hedging and investment in natural gas.
- Alternative Instruments (e.g., MUSIQ Index) to introduce bespoke indices like the MUSIQ Index that track curated market segments and offer exposure to unique investment themes.

While drawing inspiration from global trends in derivatives markets, our offerings are being carefully tailored to address local investor preferences, regulatory structures, and market maturity levels.



Beyond Derivatives

Securities Lending & Collateral Management

NG Clearing is actively exploring the integration of securities lending and collateral management solutions into its service offerings. These post-trade enhancements are designed to support liquidity, improve capital efficiency, and deepen the market. However, this is currently awaiting SEC approval to kick start.

Real Estate Crowdfunding Initiatives

Recognizing the growing interest in alternative investment channels, we are assessing opportunities in the real estate crowdfunding space. This model has the potential to democratize access to property investments through structured market mechanisms.

NG Clearing continues to position itself as a forward-looking market infrastructure institution, committed to financial innovation that addresses current gaps while anticipating future market needs. Our strategic priorities are geared towards introducing services and solutions that promote transparency, security, and efficiency in Nigeria's capital market.
